South Western Railway, Hubli Division proposes to engage 04 contract teacher in TGT and 05 contract teacher in PRT at Railway High School (EM), Hubballi, for academic year 2024-25. This scheme will be valid for a maximum period of 200 working days and a minimum period of 07 working days or availability of regular selected candidates whichever is earliest and subject to any instruction issued from time to time.

- ii. All Education certificates (eg SSLC/SSC, HSC, Degree etc)
- iii. If working NOC from the current employer
- iv. Experience certificate if any.
- v. Academic/Educational Qualification for every category must be from a recognized Insitution/Board (Mark Shee and certificate)
- vi. Caste certificate issued by the competent authority as mentioned by the government of India.

05. Terms and conditions:-

a. The engagement of the above teachers would be on full time contract basis is done for a period of not less than 07 days and not more than 200 working days. O HORLTO

- b. Contract teachers who enter into contract with the railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service rendered as part time contract will not have any right in respect of considering of their in regular selection through Railway Recruitment Board and will not form part of the cadre of railway teachers.
- c. All the candidates proposed to be engaged should be of sound physical and mental health as per Railway Medical standards. They will be subjected to medical examination and should be found fit.
- d. In case of unsatisfactory work or misconduct on part of the personnel so engaged on contract basis, Railway reserves the right to terminate the contract at any time without assigning any reasons.
- e. The maximum teaching periods allotted to such contract teachers may not exceed 05 in a day
- f. No private practice or any other employment will be permitted during the contract period.
- g. The contract teachers would perform all the jobs related to academic including evaluation work for which no over payment and above the one for taking periods will be made.
- h. The selected candidates will not be entitled to any other facility like leave, medical passes, PTO's, transportation etc.
- i. The selected candidate will be paid remuneration as noted in Para-2 mentioned above and the candidates cannot claim any additional remuneration allowances or other benefits during the course of contract period.
- j. Cor solidated payment on monthly basis may be made to the contractual teachers for the duties performed including invigilation exam related work instead of per period basis. Hithe to in force in the railway school. However the contractual teachers appointed for a period less than a month will be paid on pro rate basis only. The pro rate payment to the teachers may be regulated as under

Consolidated pay x Nur ber of days worked

- k. Candidates appointed on contractual basis will not be entitled for vacation pay and during autumn/ winter break, payment should be calculated on the pro rate basis. Those fulfilling the above conditions may apply for the above mentioned posts. Candidates while applying should indicate past service rendered if any including the period of contract put in by them on Indian railways.
- I. Candidates should have requisite academic qualification on the date of interview. Those who are appearing and/or awaiting results of final examination are not eligible. Academic and technical qualification must be from a recognized institution/Board, otherwise candidature will be rejected. Engagement on contract basis of the candidates will be subject to their being found suitable in order of merit be selection committee.
- m. The decisions of this office in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, selection, and allotment of posts to selected candidates will be final and binding on the candidates no enquiry or correspondence will be entertained in this connection. Candidates who submit forged caste certificates for securing eligibility shall be liable for rejection for the post for which he/she has applied.
